ROYAL APPOINTMENT

Her Royal Majesty Mahealani, The Queen of the Aupuni O Ko Hawaii Pae Aina (Hawaiian Kingdom Government), on this day, April 30, 2012, appoints as Senior Judge Advisor/Advocate/Mentor/, as well as judicial and economic facilitator; Judge Navin-Chandra Naidu (Silvercloud Musafir); of the Native American Association of Nations and the Northern Cheyenne Tribe's Traditional Court of Equity, not limited to performing the following functions, duties and obligations on behalf of the Hawaiian Kingdom Government:

1. Prepare a Native Code of Conduct to serve as a model for the Rules of the *Kingdom Court of Equity* based on divine law, eternal law, natural law (God's Law), Kingdom Law, and not man-made laws (formalistic and positive law) as used by state and federal governments.
2. Establish and ordain a *Kingdom Court of Equity* where precedents can be established as Customary Native Law to advance and promote the rights of the *konohiki* and *makaainana to their ahupua'a, ili, and other land divisions given in the mahele*, in order to enable the undisputed and undisturbed rights to land and soil belonging to the aboriginal People of the Hawaiian Islands since time immemorial. The doctrine of *usucapion* (Latin: ownership due to lengthened possession of land and soil) are already established in Article XII, Section 7 of the Constitution of the State of Hawai'i which constitutionally and statutorily gives force to Customary Native Law acknowledging the Hawaiian Kingdom/domain.
3. Re-examine and re-evaluate all previous unconstitutional, unconscionable, unlawful, illegal and fraudulent decisions by municipal, state and federal courts so that Customary Native Law shall set the pace and tenor for the *Makaainana* in order to overrule, distinguish, or displace those earlier disadvantageous common law decisions that are at variance with the true course and cause of justice. Alien laws should have no effect on the Hawaiian Kingdom Government under accepted principles and tenets of international law.
4. Draft documents in an effort to renewing treaty rights with the United Kingdom (1836, 1846, 1851); France (1839, 1846, 1857); Denmark (1846); *United States of America* (1850, 1875); Sweden (1852); Belgium (1862); Netherlands (1862); Italy (1863); Spain (1863); Switzerland (1864); Russia (1869); Japan (1871); Germany (1879); Samoa (1887); Hanseatic City of Bremen, Germany (1851), and other nation-states to enable resumption of diplomatic ties that were unceremoniously interrupted in 1893

when the United States invaded, occupied, and breached the earlier treaties with the Hawaiian Kingdom Government.

5. Draft, prepare and issue Constructive Notices to various state and federal agencies, instrumentalities and departments regarding the inherent sovereignty of the Hawaiian Kingdom that predates European contact. All Makaainana shall be required to carry in their persons the Foreign Diplomat ID card under the aegis and auspices of the Hague Convention of 1961.
6. Obtain an International Country Code for the Kingdom's telecommunications system to evidence the Kingdom's sovereign standing and status in the international community.
7. Issue international passports, driver licenses and other travel documents that a true sovereign state should implement and enforce based on the model of cooperation but not compromise the inherent state sovereignty of the Kingdom.
8. Ordain and establish police power as a mark of true sovereignty, suzerainty and immunity as enjoyed by the Kingdom.
9. Invoke Article 1 of the 1933 Montevideo Convention in order to announce the Hawaiian Kingdom's standing and status as a sovereign nation-state that requires no validation, acceptance, approval or permission from the state or federal governments that have illegally and unlawfully occupied the Kingdom since 1893.
10. Ordain and establish a law clinic and a law college in order to help interested and qualified *Makaainana* achieve their goals and aspirations as practitioners of the rule of law for advancing the cause of justice.
11. Advance the idea of *Makaainana* representation in state and federal legislatures as an initial tactic and strategy to displace and replace these legislatures.
