INSTRUMENT OF JUDICIAL APPOINTMENT, January 5, 2001

The Council of Chiefs and Elders herein assembled are unanimous in the decision to appoint Mr. Navinanchandran GM Naidu a/k/a Silvercloud Musafir / Navin C Naidu / Navin-Chandra Naidu, a Malaysian citizen with a Malaysian Identity Card Number 480109-71-5137; a denizen of Indian country USA; and a US permanent resident to the judicial position of **Chief Judge** under Article III United States Constitution with immediate effect. Judge Naidu's shall enjoy life tenure in Office subject to good behavior as mandated under Tribal Law. Since federal Indian law is the applicable standard in our dealings with the Government of the United States, Judge Naidu shall enjoy the rank and status as a **Federal Tribal Judge**.


The Law Team as assembled by Judge Naidu will continue their duties, obligations, assigned tasks and functions as Tribal lawyers throughout Indian country America. The Tribal Law of the Land shall be based on Ecclesiastical Law, Tribal Law, Tribal Code of Conduct, International public and private law, the Law of Nations, the United Nations Declaration on the Rights of Indigenous Peoples of 2007.

The Traditional Rules of Tribal Courts of Equity shall be designated the Tribal Rules of Court with amendments as and when required. Judge Naidu has covenanted that where the rule of law is at odds with the cause of justice Tribal Law shall prevail because we operate as Tribal courts of equity.


His Honor Judge Naidu shall perform his judicial duties, obligations & functions FOR

the advancement of the cause of justice which has been denied to our People in our Sacred Land under imported laws, rules and regulations. We invoke the blessings of the Great Spirit of Watantanka to guide Judge Naidu in his tasks. Judge Naidu has agreed to meet the pressure of his judicial tasks from nontribal municipal, state and federal courts not limited to the United States Supreme Court.

A mutually acceptable and adequate compensation package shall be arranged under strict confidentiality.
