**QUANTUM LETTER OF APPOINTMENT**  
***Mennefer Tanasi (Wəb) Native American Tribe***  
**HEREBY APPOINTS**

**CHIEF TRIBAL SUPREME COURT JUSTICE**  
**OF OUR GREAT NATION**

*COMES NOW,*

We the Council of Elders, which currently consists of Chief Emmanuel Ali Bey, Chief Kerwin Mollison Bey and Chieftainess Zara Yaffa Bey, by and through Quantum Authority from the Creator of All things seen and unseen, given authority in this physical realm by spoken word from the Legislative Assembly and appoint Navin Chandra Naidu as written herein.

**SO ORDERED, SO DECREED:**

**This OFFICIAL LETTER OF APPOINTMENT herein outlines the intention and purpose of the Assignment of Navin- Chandra Naidu as:**

- (I) Chief Tribal Supreme Court Justice of the *Mennefer Tanasi (Wəb) Native American Tribe* and**  
**(II) Chief Tribal Counselor to the *Mennefer Tanasi (Wəb) Native American Tribe* and**  
**(III) Principal Representative to the United Nations and (4) Chief Representative to the International Criminal Court.**

**ASSIGNMENT ORDERED:**

This Assignment and Appointment is established under Quantum Decree for the purpose and intent to assist ***Mennefer Tanasi (Wəb) Native American Tribe*** for immediate action and development in the following areas, including, but not limited to: Judicial development, Executive development, Economic development, Environmental development and Issuance of court orders of authority for the benefit of the nation. ***Mennefer Tanasi (Wəb) Native American Tribe*** seeks to recover ancient history, lost cultural property (tangible or intangible), treaty development, nation building, land restoration, recovery of documentations, artifacts, historical and or ancient intellectual property, as well as governmental infrastructure building, which is inclusive of the restoration of Our ancient customs, usages and culture beneficial to the continued development, existence and refinement of the ***Mennefer Tanasi (Wəb) Native American Tribe***. Prophecy as described in "Return of the Ancient Ones" is now being fulfilled through ***Mennefer Tanasi (Wəb) Native American Tribe***.

**Chief Tribal SUPREME COURT**  
**Justice**

I. The assignment to the position of Chief Tribal Supreme Court Justice, in the Supreme Court of the **Mennefer Tanasi (WOb) Native American Tribe** is hereby ordered in able to establish assistance to build our great Nation.

II. The Office of Chief Tribal Court Supreme Justice makes OATHS and PROMISES to protect, defend, uphold, respect, and fulfill all DECLARATIONS, PROCLAMATIONS, TREATIES, ROYAL FLAGS, INSIGNIA, TRIBAL CONSIGNS, CONSTITUTION and CONSTITUTIONAL AMENDMENTS, CONVENTIONS, and other ORDERS and OFFICIAL agreements and documents that have been and will be established under the OFFICE OF our Council of Elders and the Legislative body of **Mennefer Tanasi (WOb) Native American Tribe**.

**Therefore it is Hereby Decreed that:**

Under this appointment and where, in the performance of the duties delegated to this position in this appointment, the duties and authorities herein cannot be delegated to another; therefore, the Justice shall advise and direct his Office in a manner which operates in tandem with policies set forth by the Council of Elders and the Legislative body of **Mennefer Tanasi (WOb) Native American Tribe**

This Appointment commenced on July 29, 2015 , 201 5 A.D. and shall continue until the Council of Elders and the Legislative body of **Mennefer Tanasi (WOb) Native American Tribe** deems necessary to remove and/or replace the Chief Tribal Supreme Court Justice.
