We come in peace,

We hereby notify you that we are issuing Tribal Travel Permits to our Enrolled Tribal Members pursuant to Tribal Law and Federal Indian Law.

We further request that police officers patrolling our streets, freeways, highways and byways be fully cognizant of Federal Indian law germane to Indians traveling within Indian country not subject to municipal or state jurisdiction.

Please contact the Tribal Council of Elders for further clarification on this matter. We believe a meaningful dialogue between us, municipal and state governments will be a significant accomplishment of our goals and objectives not limited to revenue collection and jurisdiction. This is in keeping with the spirit and intent of all the Treaties that were concluded between the Cherokee and the United States government.
