## **Protocols for New Clans.**

### **The MBCGY-INAAN Chartering Process:**

The first step towards seeking "Clan Acknowledgement" into the Mund Bareefan Clan, Indigenous Native Association of Nations, Guale, Yamassee, Mechica, Creek, Seminole, Shushuni, Washitaw, Comanche, et al registry, is to make a formal request in writing to the central office at: [inars2014@gmail.com](mailto:inars2014@gmail.com). A copy your written request will be forwarded to the security office for your region.

There are two regions of Mund Bareefan territory, East Coast and West Coast, with The Mississippi River being the divide.

Exception as followed:

All Mechica in the region of Florida and Mississippi are referred to the West Coast Security Office, and All Mechica Nationals in the Region of Arizona and in the Northeast shall be referred to the East Coast Security Office.

Instructions for entrance are as follows:

**Mund Bareefan Clan Indigenous Native American Association of Nations -FAM Manual Protocols and Procedures for Chartering Clans/tribes**

An intensive ongoing training on the contents of Guale Indigenous History, Civics; Guale culture and past and present.

**Each Clan/Tribe Charter is an agreement between Your Clan/Tribe and the Supreme Grand Chief.**

Officials from "New States" shall go through a three-four day training process. The schedule which will be designated by the authentication office.

**There is a one-time non-refundable fee of \$5,000.00 for your Clan/tribe Charter to be paid by, US Postal Money Order, direct deposit or electronic deposit. Fee must be paid upon application; your charter is good immediately, and you may begin to work immediately.**

**Part 7 The Bill Rights of MBCG-INAAN, Indigenous Peoples, March 2003**

*enhanced*

**Article 11** Indigenous peoples have the right to special protection and security in periods of armed conflict. Clan/Tribe s shall observe international standards, in particular the Fourth Geneva Convention of 1949, for the protection of civilian populations in circumstances of emergency and armed conflict...

**No official MBCGY-INAAN office is to inhibit the work a clan/tribe has to do to fulfill its obligations to the central office. Your Clan Charter will be authorized when you pay the "Clan Charter fee" and sign your oath as Official(s)' to the MBCGY-INAAN Constitution. Again "your charter is good and you may begin to work immediately".**

**The success of your mission depends on how hard you work. We MBCGY-INAAN, will assist as much as we can and we will respect each Clan/tribe s' Autonomy.**

The INARS central office provides authentication services to MBCGY-INAAN nationals and foreign nationals on documents that will be used for legal and administrative purposes on Mund Bareefan Clan territory, in the "Untied States" and overseas.

- a. The INARS central office is responsible for signing and issuing charters under the Seal of the Supreme Grand Chief of the Mund Bareefan Clan.
- b. The Authentications Office receives, records, and accounts for fees.

Your application should be filed out and submitted to the Central Office who will again submit the information to the appropriate security office.

**Nationalization/Naturalization**

The first step towards seeking “nationalization and/or Naturalization” into the Mund Bareefan Clan-Guale Indigenous Native Association of Nations Registry, is to make a formal request in writing to the central office at: inars2014@gmail.com a copy your written request will be forwarded to the security office for your region. A personalized application will be emailed to your local chief.

**There is a one-time fee of \$1,250.00 for your Nationalization to be paid by, US Postal Money Order, direct deposit or electronic deposit.** You may get the account number from your local chief or from inars2014@gmail.com, new nationals will receive the education course, introduction and gift bag when we receive your deposit for entrance into the Association. Entrance fees must be paid upon application. The central office will not entertained/ authorize a request for any local nor regional charter of any kind until the clan charter is paid in full.

The non-refundable fee for the naturalization process is:

There will also be a security charter that your clan/tribe will need. Your regional security office will contact your local office for the processing of this charter. Each Clan/tribe security charter shall be a mutual agreement between Your Clan/tribe and the said security department.
